# Chief — Mark Forgy

The chief reported to the board Engine 341 is fully repaired and back in service, Utility 351 now has the drawers and topper installed and is pretty much built out, and Tender 376 needed a seal on the pump replaced. 376 will be a pretty spendy repair and the bill should be coming next month. The Marshall Fire has been billed for the repairs to Engine 342 and the bill has been accepted. He then updated the board on the Community Paramedic program with neighboring districts. The program will operate under one license with the cost of the license divided between the participating districts. Ember Alliance continues to work on products, mostly still mapping, but they're beginning some initial public outreach.

# Pension Board Meeting Rescheduled


The pension board meeting has been rescheduled for 6:30 pm, April 27, 2022 and will take place prior to the regularly scheduled fire board meeting.
