Chief's Report

Chief - Mark Forgy

Chief Mark Forgy reported to the board that Ember Alliance is preparing a draft of the first two of four sections for review. Last month Ember Alliance met with Mike Fassula and representatives from Jeffco Open Space and Olinger (Mt. Lindo). Jeffco Open Space seemed excited with the prospect of working cooperatively in future grant writing for large scale mitigation projects on Mt. Lindo and Mt. Falcon Parks. They're working on setting up a meeting with Xcel Energy to discuss the opportunities and limitations of right of way mitigation for November as well as a follow-up meeting with Olinger. Olinger is an eager partner in mitigation as well. Chief Forgy then announced that the district started receiving some of the State PPE Grant that was awarded, and so far, we have received some wildland stuff, the helmets should be coming soon, and the air packs are a few months away. Chief Forgy stated he was starting Capstone the next day and exclaimed the experience at Falck has been outstanding. He then reported that the district had a cyberattack earlier in the week that led to a discussion with our IT contractor who recommends upgrading to a firewall. Cost will be about \$1600 for equipment and implementation, and then \$50/month going forward. Chief Forgy stated that Geneva Glen Camp has two available dates in January for the district's awards banquet, January 14th, and January 21th. He then reviewed the call for October: 6-MVAs, 2-Medicals, 1-Gas Leak, 1-Odor Investigation, 4-Public Assists, 1-Smoke Check, totaling 16 for October and 144- year to date total.
